

2018 Industry Reporting Calendars

Petroleum and Natural Gas Act

Below is an overview of the oil and natural gas industry reporting due dates. If a due date falls on a weekend or statutory holiday, the completed form or payment is due on the next business day. To see when completed forms and payments are due in 2018, please refer to the reporting calendars attached on pages 5 and 6.

Oil and Natural Gas Reporting Due Dates	
From Royalty Payors to Mineral, Oil and Gas Revenue Branch*	
<i>Marketable Gas and By-Product Producer Allocations Report (BC08)</i>	Last day of the second month following the production month.
<i>Monthly Oil Sales Statement (BC09)</i>	Last day of the month following the production month.
<i>Petroleum and Natural Gas Remittance Advice (BC15)</i>	Last day of the month in which payment is made.
<i>Net Profit Monthly Allowable Capital and Operating Costs (BC51)</i>	Last day of the second month following the month in which the costs were incurred.
Payments – due the 25th of the month, including:	
<ul style="list-style-type: none"> ▪ deposit adjustment for oil produced in the previous month, for gas produced two months previous and for oil and gas produced from net profit projects two months previous, ▪ payment for actual oil royalties produced two months previous, and ▪ payment for actual gas royalties produced three months previous. 	
From Facility Operators to Mineral, Oil and Gas Revenue Branch*	
<i>Monthly Production Statement (BCS1)</i>	25 th day of the month following the production month.
<i>Monthly Disposition Statement (BCS2)</i>	25 th day of the month following the production month.

Oil and Natural Gas Reporting Due Dates (continued)	
From Facility Operators to Mineral, Oil and Gas Revenue Branch* (continued)	
<i>Reporting Interest Statement (BC12)</i>	20 th day of the month following: <ul style="list-style-type: none"> ▪ the month in which a new well event begins commercial production, or ▪ the month in which a change in reporting interest in an existing well event is effective.
<i>Monthly Gas Injection Operations Report (Form 15A)</i>	25 th day of the month following the reported month.
<i>Application for Producer Cost of Service (BC22)</i>	For additions or deletions to existing reporting facilities, December 31 st of each year. For new reporting facilities, the last day of the month following the month in which the facility starts operating.
From Plant Operators to Mineral, Oil and Gas Revenue Branch*	
<i>Monthly Natural Gas Plant and Processing Statement (BC19)</i>	25 th day of the month following the production month in which the gas was processed.
<i>Application for Gas Cost Allowance (BC23)</i>	For existing producer-owned plants, March 15 th of each year. For new producer-owned plants, the last day of the month in which the plant starts operating.
From Well Operators to Mineral, Oil and Gas Revenue Branch*	
<i>Notice of Commencement or Suspension of Operations (BC11)</i>	20 th day of the month following the effective date of the well status update.
Others	
<i>Crude Oil and Condensate Monthly Pipeline Statement (BC35)</i>	25 th day of the month following the month in which you receive oil or condensate.
<i>Monthly Treating Plant Statement (BC36)</i>	25 th day of the month following the month in which you receive oil.
From Mineral, Oil and Gas Revenue Branch* to Industry	
Oil and gas royalty invoices	Approximately the 10 th and 15 th of the month following the month in which the Mineral, Oil and Gas Revenue Branch receives the BC08 or BC09.
Client statements	Approximately the 20 th of each month.

Oil and Natural Gas Reporting Due Dates (continued)	
From Industry to Economics and Market Development Branch **	
Marketable gas sales invoices, and processing and transportation purchase documents	10 th working day (in BC) of the second month following the production month.

Penalties will be assessed if you do not file certain reports by the due date. The amount of the penalty depends on the report.

The following reports are subject to penalties of \$20 per day up to a maximum of \$6,000:

- *Monthly Production Statement (BCS1)*
- *Monthly Disposition Statement (BCS2)*
- *Marketable Gas and By-Product Producer Allocations Report (BC08)*
- *Monthly Oil Sales Statement (BC09)*
- *Notice of Commencement or Suspension of Operations (BC11)*
- *Reporting Interest Statement (BC12)*, if one or more interests in oil production are reported
- *Petroleum and Natural Gas Remittance Advice (BC15)*
- *Application for Gas Cost Allowance (BC23)*
- Marketable gas sales invoices, and processing and transportation purchase documents

The following reports are subject to penalties of \$100 per month up to a maximum of \$6,000:

- *Reporting Interest Statement (BC12)*, if no interests in oil production are reported
- *Crude Oil and Condensate Monthly Pipeline Statement (BC35)*
- *Monthly Treating Plant Statement (BC36)*
- *Monthly Natural Gas Plant and Processing Statement (BC19)*
- *Net Profit Monthly Allowable Capital and Operating Costs (BC51)*
